Minutes of Meeting

Souris River Joint Water Resource Board

Thursday, November 1, 2018

A regular meeting of the board of directors of the Souris River Joint Water Resource Board was called to order by Chairman David Ashley at 4:00 p.m. on Thursday, November 1, 2018, in the Community Room of the Minot Auditorium, in the City of Minot, North Dakota. Joint Board members attending the meeting were David Ashley, Dan Jonasson, Clif Issendorf, Roger Sauer and Tom Klein. A roster of those in attendance is attached as **Attachment A**. Chairman David Ashley called the meeting to order and announced that a quorum was present.

The Joint Board discussed the proposed Agenda for the meeting.

Roger Sauer moved to approve the agenda, as presented. Dan Jonasson seconded the motion. The motion passed without opposition.

The draft Minutes from the October 4, 2018, meeting were discussed.

Dan Jonasson made a motion to approve the Minutes from the October 4 meeting. Tom Klein seconded the motion. The motion passed without opposition.

The Joint Board discussed the Budget Report included in the November Board Packet. Ryan Ackerman provided information to the Joint Board regarding the Budget Report.

Roger Sauer moved to approve the Budget Report. Clif Issendorf seconded the motion. The motion passed without opposition.

Ryan Ackerman provided an update regarding the current audit for the previous two years of financial information. Ryan Ackerman indicated that the draft report had just been received by Ackerman's office. Ryan Ackerman indicated that the Joint Board had been keeping financial records on a cash basis, instead of an accrual basis, which is appropriate under the governmental accounting standards. In addition, one entry for a StARR program refund was counted as income instead of a reduction of expenses.

The Joint Board discussed bills. Ryan Ackerman provided an updated bill summary showing \$3,978,929.27 in bills, which is attached as **Attachment B**. Ryan Ackerman provided an explanation regarding the differences in bill summaries.

Dan Jonasson made a motion to approve the bills in the amount of \$3,978,929.27. Roger Sauer seconded the motion. The motion passed without opposition.

Jerry Bents from Houston Engineering provided the Joint Board with a presentation on Phase MI-1 construction, which included a drone video. Jerry Bents also provided an update to the Joint Board regarding the status of MI-5 design.

Jason Westbrock from Barr Engineering provided the Joint Board with an update for Phase MI-2/3 construction, which included a drone video. Jason Westbrock indicated that design on Phase BU-1 was progressing.

Dennis Reep from HDR Engineering provided an update to the Joint Board regarding the work being done in relation to the rural bridge replacements at the Mouse River Park, Sawyer, and Velva.

Ryan Ackerman provided an update to the Joint Board regarding the StARR Program. Ryan Ackerman indicated that the updated appraisals have been received in relation to the appeal hearings held in September, and that the StARR Appeals Committee will be convening to discuss.

Ryan Ackerman provided an update regarding the USACE Feasibility Update. The Chief's Report will be issued in February, 2019. Congress recently passed a WRDA bill (now known as America's Water Infrastructure Act of 2018), which did not provisionally authorize the Project.

Ryan Ackerman and Jack Dwyer discussed upcoming acquisitions for real property interests lying outside of the City of Minot's corporate limits with the Joint Board. Jack Dwyer directed the Joint Board's attention to a legal memorandum contained in the Board Packet at page 237. For acquisitions lying outside of the corporate limits of the City of Minot, the Joint Board discussed having Ackerman Estvold make the initial negotiations under the "quick take" eminent domain process for easement interests and under the traditional eminent domain process for fee title interests, and referring unsuccessful negotiations to Dwyer Law for formal process. Ryan Ackerman indicated that there was an estimated \$5 million of acquisitions, and that the acquisitions qualified for state cost share.

Clif Issendorf moved to approve the three proposed actions identified in the legal memorandum on page 239. Roger Sauer seconded the motion. The motion passed without opposition.

The Joint Board discussed upcoming meetings.

There being no further business, the meeting was adjourned.
